

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. CAMP ELIM (the “Camp”) has put in place preventative measures, including the Camp’s Reopening Plan which has been reviewed and approved by the Teller County Board of Health (the “Reopening Plan”), to reduce the spread of COVID-19; however, it is impossible to eliminate the risk of contracting COVID-19.

READ CAREFULLY BEFORE SIGNING

By signing this Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19 (the “Agreement”) you **acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that you may be exposed to or infected by COVID-19 during your stay at the Camp, and that such exposure or infection may result in personal injury, illness, permanent disability, and death.** You understand that the risk of becoming exposed to or infected by COVID-19 is impossible to eliminate, and may result from the actions, omissions, or negligence of yourself and others, including, but not limited to staff, directors, volunteers, employees and program participants and their families.

You voluntarily agree to assume all of the risks of being exposed to COVID-19 and assume sole responsibility for any injury resulting from such exposure, including but not limited to personal injury, disability, death, illness, damage, loss, claim, liability, or expense, of any kind, that you may experience or incur in connection with your participation at the Camp. You hereby release, covenant not to sue, discharge, and hold harmless the Camp, including its subsidiaries, affiliates, shareholders, directors, officers, members, managers, employees, representatives, agents and assigns (collectively with the Camp, the “Released Parties”), of and from all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto (the “Claims”). You agree that this release includes any Claims based on the actions, omissions, or negligence of the Released Parties, whether a COVID-19 infection occurs before, during, or after your participation at the Camp.

You represent that you have adequate insurance to cover any injury or illness you may suffer or cause while participating in this activity, or else you agree to bear the costs of such injury or illness yourself. You further represent that you have no medical or physical condition which could interfere with your safety during your stay at the Camp, or else you are willing to assume – and bear the costs of – all risks that may be created, directly or indirectly, by any such condition.

By signing this Agreement, you agree that if you are exposed to or infected by, or experience symptoms of COVID19 at any point during or subsequent to your stay at the Camp, you waive your right to maintain a lawsuit against the Released Parties for any Claim.

You acknowledge and agree you have had sufficient time to read this entire Agreement and to review the Reopening Plan. You acknowledge and agree you have understood this Agreement and fully agree to be bound by its terms and to submit to all health procedures implemented by the Camp or any governing authorities and agree to not rely on the Camp to cause such compliance with these health procedures.

Refusal to sign will prohibit entrance into camp.
